BOARD MEMBER REPORTS

Board Chairperson Report

The Board Chairperson received an email from Premier Wall announcing wage freezes for government officials. It was noted that out-of-scope staff of post-secondary institutions will also be asked to follow suit. The CEO will provide a further update later on the agenda.

ASRC UPDATE

The next ASRC meeting is set for March 26, 2015.

Labour Relations Consultant Update

The monthly time allocation of the Labour Relations Consultant was reviewed and received for information. The CEO Council has made a standing request to receive a time allocation update at each meeting. The other concern raised was the lack of advocacy work. The CEO Council is considering employing someone part-time to manage the advocacy piece for ASRC.

Regional College Economic Impact Assessment

The CEO presented the Provincial Regional Colleges' Economic Impact Assessment prepared by Praxis Research/Strategy dated January 28, 2015. The results show that Regional Colleges are a more efficient employment generating tool than a provincial university. These results will be shared with the MLAs as part of an evolving advocacy strategy.

Break and Enter

The CEO reported that there was a break and enter in mid-January of the sea can at the welding shop; there was no theft or damage. The City of Humboldt has a new bylaw that limits the color and location of sea containers.

Punnichy Church

Carlton Trail has investigated the option to lease the church in Punnichy. The Director of Finance met with the Punnichy Village representatives and negotiated an agreement to lease to own. After 10 months of leasing, purchase of the facility will be considered. The Introduction to Mining program will begin using this facility in March.

Fiscal Restraints Initiative

In accordance with the direction provided by Minister Doherty, Carlton Trail College has reduced discretionary spending through to the end of the current government fiscal year. A few examples include: the elimination of out-of-province travel and PD activities, cancellation of the January staff in-service and the spring open houses as well as the deferred purchase of marketing aids.

Cancellation of Post-Secondary Leadership Forum

Due to the reduced spending initiative, Advanced Education cancelled the Leadership Forum scheduled for May.
