

Coverage for prescription drugs, dental care, health services, and more, helping with costs your provincial health plan doesn't cover

Health Benefits	Coverage	
Prescription Drugs	80%	Up to \$3,000 per benefit year for medications listed under the Saskatchewan Formulary with a generic rider.
	100%	Vaccines: Influenza, Hepatitis B, Varicella, Meningitis B, Tdap or MMR. Up to \$150 per benefit year.
	80%	Smoking Cessation products: \$500 per benefit year.
Vision Care	\$50	An eye examination is covered once every 24 consecutive months. The services must be performed by a licensed Optometrist or Ophthalmologist.
	\$100	Eyeglasses or contact lenses are covered once every 24 consecutive months.
	\$150	Laser eye surgery is covered per benefit year.
Paramedical Practitioners	\$40 per visit	Up to \$400 per benefit year per practitioner for services from athletic therapists, chiropractors, dieticians*, registered massage therapists*, naturopaths, osteopaths, physiotherapists, podiatrists/chiropodists and speech language pathologists. *Physician's referral required.
Mental Health Practitioners	\$40 per visit	Up to \$400 combined per benefit year for services from registered psychologists, qualified social workers, psychotherapists, therapists, or counsellors. Eligible practitioners are listed on the website.
Medical Equipment & Supplies	100%	This includes, but is not limited to, walkers, braces, prosthetics, crutches, canes, splints, trusses, wheelchairs, hospital beds, custom-made orthopaedic shoes and orthotics. Requires prescription and medical necessity. Pre-determination recommended.
Ambulance Services	100%	Reasonable and customary charges for emergency transportation to the nearest hospital, including air ambulance services.
Hospital	100%	Upgrade from public ward to semi-private room.
Private Duty Nursing	100%	\$25,000 during any 3 consecutive benefit years. Prescription and pre-authorization required.
Dental Accident	100%	Reasonable and customary charges per accident for the repair or replacement of healthy, natural teeth that are damaged by sudden impact. Treatment must be completed within 12 months of the accident.
Emergency Travel Assistance	100%	Up to \$5 million per benefit year for emergency expenses on trips for vacation, business or education purposes originating from Canada.
Tutorial Insurance	\$10 per hour	Up to \$300 per condition if a student has been confined to their home or a hospital for at least 7 consecutive school days.
Accidental Death & Dismemberment	-	Loss of life, limb, or paralysis due to an accident, with a life benefit of \$5,000.
Dental Coverage is a combined maximum of \$750 per benefit year. Ask your dentist to submit a predetermination to TELUS Adjudicare prior to any dental treatment plan exceeding \$500.		
Dental Benefits	Coverage	
Preventive Services	80%	Complete oral examination every 36 months, one recall examination per benefit year, and a full series X-rays every 36 months. 1 unit of polishing and up to 4 units of scaling once per benefit year. Removal of impacted teeth and related anaesthesia.
Basic Services	70%	Amalgam and tooth-coloured fillings.
Other Basic Services	60%	Root canal therapy, 8 units combined of root planing, occlusal adjustment and equilibration per benefit year.

Enrollment Confirmation

Eligible domestic and international students are automatically enrolled in the Student Benefits Plan — no application needed.

Check your student account statement for health and dental insurance fee to confirm enrollment.

Validation Period

New enrollments have a validation period of up to 60 days starting from the term's beginning. During this time, pay out-of-pocket for eligible expenses and keep your receipts to submit online claims once the validation period ends.
